The Contest

1. The BBQ Mania I, Barnyard Smackdown BBQ Cookoff (Cookoff) will be held Friday October 3 and Saturday October 4 at Fontainebleau State Park in Mandeville, LA. There will be a \$1 a person entry fee for the park.
2. Proceeds from the Cookoff will go to Children's Hospital in New Orleans. Children's Hospital is a 501(c)(3) non-profit hospital providing care to the children of Louisiana without regard to their family's ability to pay. You are responsible for keeping the records necessary for tax purposes.
3. The competition is open to everyone, professionals and amateurs. There is no limit to the number of cooks on a team.
4. Registration and set-up will begin on Friday, October 3rd at 8:00 a.m.. All contestants must be registered and in place by 6:00 p.m. October 3rd.
5. Water and electricity is provided.
6. The deadline to enter is October 1, 2008.
